After Thomas Cook's insolvency: Takeover of SENTIDO by DER Touristik confirmed

Takeover of hotel brand SENTIDO confirmed by DER Touristik

Cologne/Frankfurt a. M., 04.12.2019. DER Touristik acquires the trademark rights to the hotel brand SENTIDO from Sentido Hotels & Resorts GmbH. This enables the franchise hoteliers to continue operating the brand with a strong partner, in particular from the German source market. The negotiations between the insolvency administration and DER Touristik have thus come to a successful conclusion. "With the sale of the well-known hotel brand SENTIDO, the future of another part of the Thomas Cook business will be secured", says Julia Kappel-Gnirs, insolvency administrator of Sentido Hotels & Resorts GmbH.

"We are delighted to have found a buyer in DER Touristik who we are convinced will be able to offer our long-standing franchise partners and certainly many new partners a good future," adds Jan Mayer, Managing Director of Sentido Hotels & Resorts GmbH. The SENTIDO brand stands for four- and five-star hotels with strong demand from Germany, Austria and Switzerland. The well-known and very popular brand SENTIDO is characterized by high-quality hotels with a high recommendation rate. SENTIDO focuses on hotels for couples and family holidays around the Mediterranean. The takeover is subject to approval by the antitrust authorities.

In the meantime, the Bad Homburg Local Court has opened further insolvency proceedings against the assets of Thomas Cook Vertriebs GmbH, Sentido Hotels & Resorts GmbH, Thomas Cook Airport Service GmbH and NeckermannUrlaubswelt GmbH.
